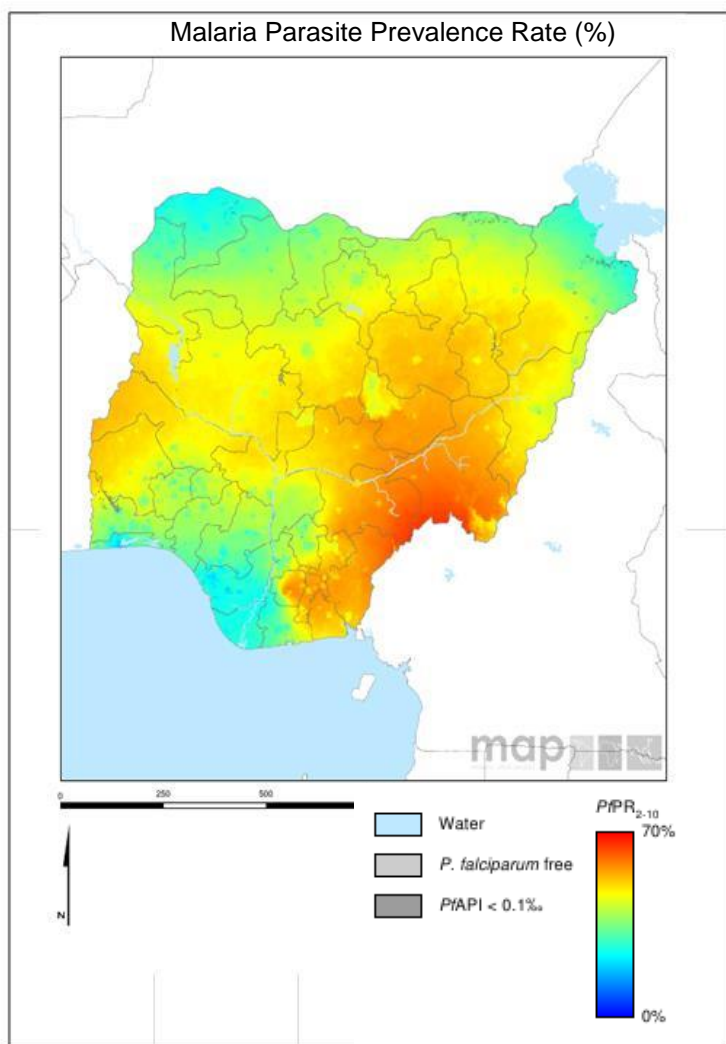

Progress

Nigeria has banned oral artemisinin-based monotherapies and introduced a policy on Community Case Management for malaria and pneumonia. The development of the Saving One Million Lives initiative in 2012 is expected to accelerate progress in tracer MNCH intervention coverage and the tracking of these indicators will be enhanced through the Saving One Million Lives Scorecard.

Impact

The annual reported number of malaria cases in 2013 was with 12,830,911 cases and 7,878 deaths.

Key Challenge

- Funding gaps to achieve and sustain universal coverage of all malaria interventions to 2015 and beyond.
